## ÁLVARO GALINDO FAIR AND EQUITABLE TREATMENT

Mr. Alvaro Galindo is an international arbitrator and international counsel advising on complex arbitration matters. His practice focuses on disputes between sovereign states, state-owned entities, and private companies. She teaches Arbitration and Oral Litigation at Universidad de Montevideo (UM).
